Brothers,

As the summer winds down, many of you will be preparing yourselves or your children for the ritualistic return to academics. The Eta Iota House Corporation is also preparing for the return of undergraduate activity to the House.

### PETERSON AWARD

Congratulations to the undergraduates for achieving a Peterson Award for 2010. This is the first Peterson since 2005, having come within a half point of winning the award last year and finally achieving success this year. The award was presented to the Brothers of Eta Iota during the annual Balfour Leadership Training Workshop (BLTW) held at the University of North Carolina, Chapel Hill. The Eta Iota House Corporation was represented by HC Trustee Brian Lojko and HC Executive Vice President Nick Weiss. Nick was attending workshops conducted by the Grand Trustees, learning and sharing best practices regarding House issues. Brother Lojko was heard saying, "I really want to relive my undergraduate days," and attended BLTW simply to enjoy the plush housing accommodations and Vegas style food buffet.

### FIRE ALARM AND MONITORING SYSTEM

The House has a newly installed fire alarm and monitoring system. The project is the culmination of many month's worth of preparation, estimates, and work with the contractors and Sigma Chi Headquarters. The Risk Management Foundation, the insurance mechanism of Sigma Chi, mandated last year that this type of system be installed in order to lower the overall fire risk and to better protect our brother's and our asset. In order to help defray the cost of this type of upgrade, RMF offered a \$3,000.00 grant and the insurance company proposed a \$600.00 yearly premium deduction for those chapters complying with the change. When the project was finished, the upgrade cost approximately \$8,000.00, (\$5,000.00 when deducting the grant), and with the grant and yearly premium deductions, an ROI will be realized in approximately 8 years with a system life expectancy of 10-15 years. Monitoring of the system is internet based and the cost of the monthly service is paid by the undergrads.

### 40<sup>th</sup> BIRTHDAY

Plans for the 40<sup>th</sup> Birthday are well underway. The date has been set for Thursday, March 31<sup>st</sup> through Sunday, April 3<sup>rd</sup>. Registration and specific event activity information will be available starting October 1<sup>st</sup> through our website, [www.etaiota.org](http://www.etaiota.org). In order to ensure fiscal success and to relieve the burden of planning the entire event from one individual,

the birthday chairperson role has been streamlined to a committee (team) format. The new voluntary committee consists of Brothers James "Gassi" Ahrens, Brian Lojko, and Rich Schooley. Collectively, they will coordinate and help execute many of the weekend events. Additionally, there will be opportunities for alumni brothers to donate either products or services that will be part of a silent auction or similar fundraising event during the birthday weekend. A formal process for donating will be forthcoming.

## HVAC (Heating, Ventilation, & Air Conditioning) INSTALLATION

The second phase of the central A/C system is underway. The south wing will join the north wing in having an updated HVAC system, which will replace the existing wall units. This \$12,000.00 capital improvement project began in the fall of 2009 and should be complete by the end of September, 2010. The upgrade should lower utility costs while at the same time eliminate mold and condensation damage created by the old wall units; this will also reduce/eliminate A/C replacement costs (which has been an annual budget burden).

## WINGS AND WAVES

Embry Riddle is hosting another, "Wings and Waves" airshow and alumni weekend October 9<sup>th</sup>-10<sup>th</sup>, (not to be confused with homecoming scheduled for November 5<sup>th</sup>-7<sup>th</sup>). The Eta Iota HC has not planned for any formal events to coincide with either weekend due to the financial focus of our own 40<sup>th</sup> birthday party. However, if you are in the area that weekend(s), stop by the House and spend some time with the brothers as we are certain they will they will have their own RMF compliant non alcoholic activities planned.
