# ANNUAL HOUSE CORP MEETING RECAP

For those of you who missed it, The House Corporation's annual meeting started out smooth enough with an offer from ERAU officials to present us with the University's master plan - what a mistake! They had no reference to any plans for Greek housing but we delivered the message loud and clear of our disapproval. See the article on page 1 for a follow up on this matter.

After the fireworks, we moved on to officer elections and a review of current issues facing our chapter and House Corporation. Not surprisingly, house maintenance is at the top of the list for expenses we face on a regular basis. Some of the ideas tossed out to address this concern focused on A/Cs and plumbing. We recently replaced the air conditioning in the main house and we will investigate doing the same for both wings. This would involve putting both wings on central air and getting rid of all of the window units that have proven to be a costly maintenance problem.

Water leaks from pipes or the roof have also plagued us from time to time. While replacing the entire plumbing is an option, it probably isn't viable at this time due to the enormous costs involved. We will, however, have an opportunity to concentrate on specific plumbing problems in the upcoming room renovations. We are currently reviewing possibilities for how we can refresh some of the more problematic rooms (some may even be described as *craptacular*) with renovated bathrooms and new drywall & paint.

Financially, we are looking pretty good at this point. The only follow up items from the meeting are to review our current tax situation and look into investment possibilities for 1855 Club contributions. Aside from that, we have been able to contribute to long-term savings while at the same time managing significant house improvement projects like the A/C mentioned above, new carpeting, furniture, electrical work, and new columns for the front porch.
